

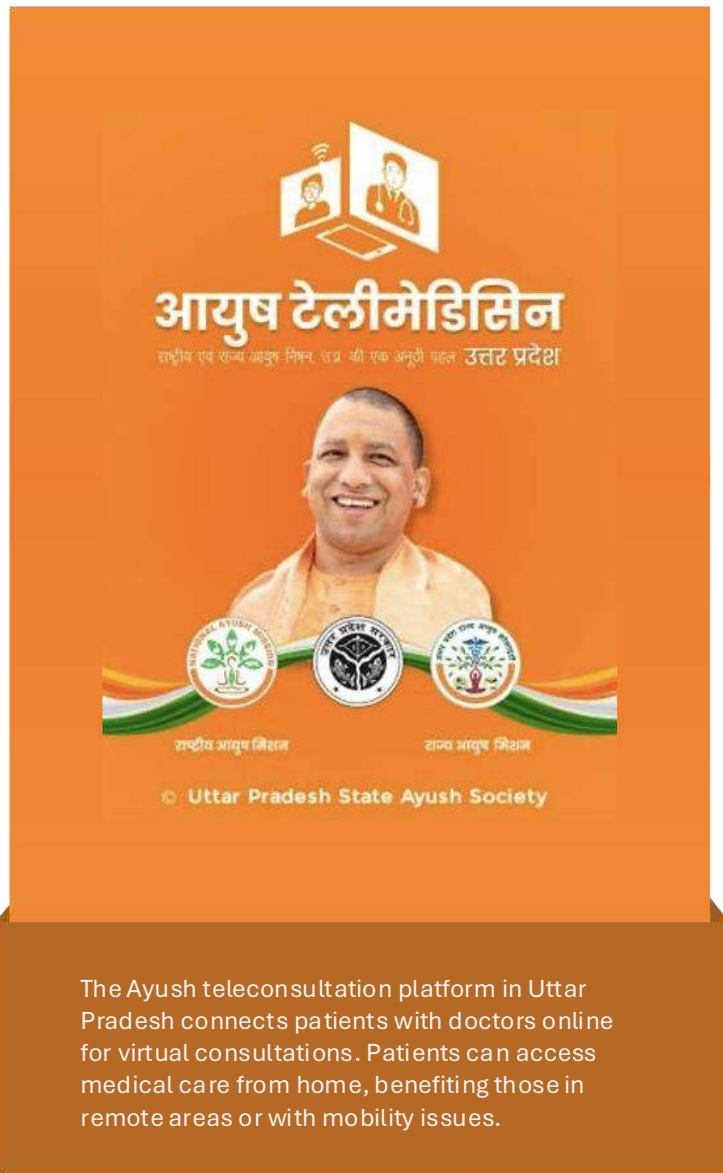

Telemedicine enhances healthcare systems by improving access, efficiency, cost-effectiveness, and the patient experience.







PeopleLink offered a complete telemedicine and tele-learning customized solution/application, which included an Android-based app that allows users to access the system from their mobile devices.

02

The solution also included a web app, which can be accessed from any internet-enabled device, providing greater accessibility to users.

03

The application included a Management Information System (MIS), reports for monitoring telemedicine solution performance and usage.

04

An Alerts system was also implemented in the application to notify practitioners and patients of upcoming appointments or important information.

05

The solution also provided a dashboard for practitioners and patients to view their appointments, treatment history, and other important information.

06

Video Calls & Cloud Services enabled virtual consultations for practitioners and patients. They also secure storage for medical records, images, and related documents.
